## **Welcome and Introductions**

Meeting called to order @ 5:30pm, introductions were made around the table. Expecting our facilitator (Dani) will be back for the November meeting.

### **Safety Orientation**

Erin reviewed safety procedures.

#### Erin Badesso -

Motion to adopt last meetings minutes – passed. Minutes will be posted.

## Action Items from WFP Feb 21st, 2019

- 1. Audit Report Summaries Let the group know when the summaries are posted
- 2. New Proposed Bear Den/Eagle Nest Strategy to be reviewed by group May 23rd
- 3. Pre & Post Road Deactivation Erin to bring pictures showing favorable soil conditions that allow effective reforestation Erin showed pictures from Fauna 900. Discussion around soil horizon material. The operator used an excavator to "plant" a few 4-5 meter tall trees recovered from the road fill-slope.

#### WFP operational Update – J Muress

 WFP logging in the Alberni Valley is at full capacity. APD was shut down due to the lumber market and are supposed to go back April 15<sup>th</sup>. Erin and Jim attended an official signing for *TFL44 Limited Partnership*. (The TFL has been sold to the Limited Partnership as discussed in our past February meeting.) There are discussions of the name being updated. WFP staff is managing the TFL on behalf of the Limited Partnership. TFL 44 is still crown land.

Action Item 1 – Erin to bring pictures of the signing ceremony

**SFM Plan Dataset** – E Badesso to present remaining CSA indicator data for 2018 Some indicators were reviewed last meeting. Note: during the presentation of indicators example photographs were displayed for additional context.

Indicator 1.1.1 – Target for CWHvh1 – not met. Result was recorded and discussed in the context of harvest history and progression in the Defined Forest Area (DFA).

Indicator 1.1.2 – Target met on tree species composition

Indicator 1.1.3 – Target met. The definition of the productive forest was updated, which is why our number of productive hectares is slightly lower than last year. Erin explained how the definition of productive forest was adjusted in 2018.

Indicator 1.1.4 – did not meet target – were within the variance. The amount of cable yarding affected the retention level, as it makes it more difficult. 48% of harvesting was cable yarding in 2018. The planning team is aware of this and will address it going forward. Action Item 2 – Future discussion needed on how retention levels are/should be calculated for this indicator to more closely align with broader corporate reporting of retention levels.

Indicator 1.2.1 – Target met. Type of habitat and species protected. Changes from 2017, some adjustments to the allocation of legal, proposed and voluntary.

Indicator 1.2.2 – Target met. This is an indicator is reviewed every 5 years. 2013 compared to 2018. Total area in reserves are up overall from 2013.

Indicator 1.2.3 – discussed last meeting – followed up with pictures. Photos of Red wood planted in the Klanawa. Noble Fir picture too.

Indicator 1.4.1 - met the target. 18 blocks in 2018 required archaeological assessments and

three had confirmed culturally modified trees.

Indicator 1.4.2 – Target met. The number is up from 2017 because of increased harvesting and also because Big Trees are now captured in the report. Action Item 3 - Stickleback Lake: send addition information to Rick Avis.

Indicator 2.1.4 – harvest level was higher in 2018 as the company is working to meet its five year allowable cut. In 2012 and 2013, WFP was behind in its cut control, and worked to catch up to harvest 104%. If cut is above 110%, the government charges additional stumpage fees.

Indicator 3.1.1 – Soil Disturbance Target Met

Indicator 3.1.2 – Down Woody Debris. Target Met. Discussion on changes to the government methodology to determining waste. For cutting permits approved after April 1 the penalty will be 3x the stumpage rate. Waste benchmarks have also been adjusted resulting in greater penalties to be paid. This logic is to promote greater recovery to better support the pulp industry. Waste surveyors have to assess how much was avoidable and unavoidable waste. Very little is used as biomass.

Indicator 3.1.2a – Limit Herbicides. Target met – Half hectare treated in 2018. Target species was Japanese knotweed.

Indicator 3.2.1 – Target met.

Indicator 3.2.2 – Target met – First year reporting on this indicator

Indicator 3.2.2c – Target not met, still within variance (S4 Streams). S4 streams are typically associated with flatter lands.

Indicator 3.2.2d – Target met (S5 streams). S5 streams are typically associated with gullies and tougher terrain. Discussion around storm debris affecting streams.

Indicator 4.1.1 – Net Carbon Uptake – Target met. Expect to stay carbon positive when harvesting the AAC. If a big harvest year, the value might dip into the negative. Pile Burning? Are we going to continue? Pile burn to abate a fire hazard and to create more plantable area. Not a lot of opportunity to utilize the debris piles in other ways.

Indicator 5.1.1 – target met. On average, stumpage rates were \$3.00 higher in 2018 compared to previous year

Indicator 5.1.2 – Target met. Reviewed an email exchange regarding pile burning and smoke management.

Indicator 5.1.2a – Park Perimeter – Target met

Indicator 5.1.2c – Mushroom habitat – target met

Indicator 5.2.1 – Target met – Updated indicator from previous years. Reflects being mindful of community activity – example: road grading and maintenance of Bamfield Mainline

Indicator 5.2.2 – Target met – Training to keep current with the forestry industry

Indicator 5.2.3 – did not meet target – 5 year rolling average. A brief discussion on labour input for harvesting old growth vs. second growth. Second growth harvesting requires less labour but this variable is not a factor in determining the results for this indicator.

Indicator 6.1.1 - Satisfaction survey – Target met

Indicator 6.1.2 – Educational sessions – Target met

Indicator 6.1.3 – Target met - WiWag minutes and presentations are posted on the website

Indicator 6.2.1 – Target met - Improve Safety Standards. Medical Incident Rate only slightly decreased from 2017.

Indicator 6.2.2 – SAFE Certified – Target met

Indicator 7.1.1 – Target met – First Nations training completed.
