🔥 Fire extinguishers are mounted on the walls near all building exits of the Administrative Office. These areas are indicated by illuminated "EXIT" signs. In the event of a fire, leave by the nearest exit and marshal outside the marshaling yard gate by the Administration Office sign.



- + A first aid kit is mounted on the wall at the base of the stairs in the main Administration Office. An eyewash bottle is kept in the middle restroom.
- 🌐 In the event of an earthquake, duck for cover and wait for the shaking to stop. Emergency lighting will be engaged in the event of a power outage.
- ♣️ The restrooms are located on the lower floor of the Administration Office Building.
- 🚭 The building is designated as non-smoking. Ashtrays are provided outside the exits for those who wish to smoke. Thanks for your understanding and consideration.

If you plan to drive, please follow these safety precautions:

- Wear your seat belt and drive with your lights on.
- Ensure your vehicle is safe to operate, with enough fuel, a first aid kit, a spare tire and a jack (carry chains in the winter).
- Have a clear understanding of your route (your Western Forest Products Inc contact can provide you with a map if necessary).
- Drive to road conditions and obey the posted speed limits (60 km/hr on mainlines and 50 km/hr on spur roads).
- Expect to encounter industrial equipment at any time, 24 hours/day, 7 days/week. Yield the right-of-way to industrial equipment (pull over in a wide spot) and do not pass until the Operator signals for you to do so.
- Bridges are single-lane and visibility is often limited; do not attempt to meet other vehicles on them.
- Do not proceed through falling or blasting signs without clearance from the employee in charge of the area.



Help us keep Port Alberni Forest Operation green & clean

- Dispose of refuse in the proper receptacles where possible. If none is available in the area you are in, please bring any garbage back with you.
- In the event of an oil spill, please notify a Western Forest Products Inc employee immediately so that the spill can be contained quickly.
- If you plan to smoke while in the woods, ensure your cigarette / matches are disposed of safely. If you choose to light a campfire, monitor it closely and ensure it is completely extinguished before leaving it. Should you see smoke or fire, report it immediately ([1-800-663-5555](tel:1-800-663-5555)).
- Take care to protect our waterways. Do not dump substances in any creek or stream. Please make use of the portable lavatories if you are visiting an area in or near a watershed.
- Do not leave your vehicle unattended on the outside curves of logging roads, on bridges or anywhere else where it may obstruct traffic.
